

## **Chronicle Photography**

### **Win Your Wedding Photography Competition: Terms and Conditions**

These terms and conditions ("Terms") are supplemental to and should be read in conjunction with any specific entry instructions or terms applying to the particular competition ("Competition Information"), and in the event of inconsistency, these Terms shall prevail.

All entrants must comply with the entry requirements set out in the Competition Information and these Terms to enter a competition. The entrant is aware that failure to comply with the competition information or the terms may result in their disqualification from the competition.

Chronicle Photography reserves the right to update/amend these terms at their sole discretion, and any changes will become effective as soon as they are published on the appropriate site/publication.

#### **ENTRY REQUIREMENTS**

The following ARE NOT eligible to enter Chronicle Photography's Win Your Wedding Photography: employees and freelancers, or members of their immediate families (who are either spouses, parents, children or siblings), of: Chronicle Photography; Or any company or sponsor associated with a specific competition.

Unless otherwise stated in the competition information, entry to this competition is restricted to entrants who are residents of Scotland, in the United Kingdom..

The competition is only open to people aged over 18 years old.

Chronicle Photography reserves the right to require entrants to provide proof of identity as evidence of eligibility to participate. In the event that an entrant does not comply with a request to provide proof of identity or furnishes any false/misleading information Chronicle Photography may, at our sole discretion, disqualify the entrant from the competition entirely or, where appropriate, allocate the prize to another eligible entrant. This decision will be final, and no correspondence will be entered into about a decision regarding eligibility.

#### **ENTRY**

Entry into Chronicle Photography Win Your Wedding Competition is free of charge.

Entries must be submitted following the specified format in the competition information. Proof of making a phone call, sending an e-mail or posting is not proof of receipt of your entry, and Chronicle Photography will accept no responsibility for lost, damaged or delayed entries or entries that are not received for any reason.

Chronicle Photography will specify the closing date for entries in the Competition Information (and this may be extended at the absolute discretion of Chronicle Photography), and winners will be notified on the date specified in the Competition Information. Any late entries will not be accepted, but the participant may still incur any associated costs.

Incomplete or illegible entries will not be counted and will be discarded. Chronicle Photography has no responsibility to inform any entrant that their entry is incomplete or illegible or not valid for entry to a competition.

Chronicle Photography is not liable for any associated cost to entrants, winners, parents, or guardians of entering a competition or claiming a prize unless expressly specified in the Competition Information.

Entrants (including the winners) hereby assign all intellectual property rights and waive all moral rights in their entry to Chronicle Photography Win Your Wedding competition. Entries cannot be returned to entrants unless Chronicle Photography explicitly agrees.

Where materials are returned to the participant, Chronicle Photography accepts no responsibility for the safe return of any material or its return in an undamaged condition or any liability for loss or damage to such material.

Winning couples may be asked to share their story and preparations with Chronicle Photography, who may share all or part of that information to their public facing channels and media, including but not limited to social media, printed press, TV, website. .

Where Chronicle Photography is not available to provide photography coverage for the winner, Chronicle Photography will supply an associate to fulfil the photography service on the wedding date and Chronicle Photography will provide the editing and delivery of the photographs.

Unless expressed otherwise in the Competition Information, if, for any reason, Chronicle Photography is unable to contact a winner to inform them that they have won a competition, or if a winner does not contact Chronicle Photography within a reasonable period of Chronicle Photography sending notification to such winner to confirm acceptance of a prize, then Chronicle Photography reserves the right (in its sole discretion) to select an alternative winner.

## PRIZE

The couple selected by a random number generator will be deemed the winner and will receive the wedding photography package. This will be Chronicle Photography's 'Essentials' photography package or equivalent if it is replaced in future.

The package currently includes:

- Approximately 8 hours of photography coverage
- 1 photographer
- Online gallery
- Digital delivery of photographs
- Print and share licence for the couple
- Next day preview images

Chronicle Photography reserves the right to amend the prize package.

There is no cash alternative to any part of this promotion or its prizes.

No refunds are available for any reason on any part of the prize.

If the winners cannot take up the prize for any reason, Chronicle Photography reserves the right to offer the prize to another entrant also selected at random.

The prizes offered in competitions may be provided by a sponsor (or alternative promoter) rather than Chronicle Photography. In such circumstances, Chronicle Photography does not accept any responsibility for the accuracy of any prize descriptions supplied by such third parties.
